EDUCATION & COMMUNITY PROGRAMS: Create and implement the various programs, festivals, art and craft shows and tours in and around the Old Church Complex, including but not limited to the monthly free speaker series, Heritage Day celebration, annual mudding day experience and Heart of Corrales Festival in conjunction with the Village-wide Harvest Festival. These events draw locals and tourists of all ages to the community and to the Old Church. Workshops provide an opportunity to learn skills that have been passed down for generations and are unique to our New Mexico culture.
